



OVERVIEW

MMWD is offering a rebate for EPA WaterSense labeled smart irrigation controllers – ones that self-adjust based on the weather. This offer is available to residential and commercial customers with active MMWD potable water services. Participants must install and program the WaterSense irrigation controller according to manufacturer’s specifications and applicable codes and regulations. Rebates are offered on a first-come, first-served basis, subject to the availability of funding.

REBATE AMOUNT

Up to \$100, not to exceed actual cost.

TO APPLY

1. Purchase and install a qualifying smart irrigation controller from the EPA WaterSense list: <https://lookforwatersense.epa.gov/products/>. For help determining if a smart irrigation controller is right for your property, contact us at 415-945-1527 to schedule a site visit.
2. Submit your application form and purchase receipt.

3. MMWD will contact you to schedule a site visit to verify installation and review irrigation scheduling.
4. After successful completion of the inspection, a rebate check will be mailed to you.

ELIGIBILITY

- You must be the owner of property receiving potable water service from MMWD or an existing customer of MMWD with an active potable water service.
- If you are not the owner of the property where the WaterSense irrigation controller is installed, you are responsible for obtaining necessary permissions from the owner before applying for this rebate.

TERMS & CONDITIONS

- Only qualifying WaterSense labeled irrigation controllers purchased on or after 5/15/2020 are eligible for a rebate.
- Submit receipts within 90 days of purchase.
- Limit: one controller rebate per site, including controller rebates offered through other MMWD programs, unless additional rebates are approved in advance.
- Rebates are offered on a first-come, first-served basis and are subject to availability of funds.
- Rebates will be paid to the name and address as it appears on the water bill, unless applicant is not MMWD Water Account Holder.
- Purchase receipts must be submitted with the application.
- If submitting original receipts, please make copies for your records. Receipts will not be returned.
- Receipts must be legible and itemized to clearly show what has been purchased. If submitting an invoice from a contractor please ensure it includes the name and address of the contractor, itemized dollar amount of qualifying purchase, zero balance due, product brand and model. Receipts will not be returned—please make copies for your records.
- Rebates are offered at up to \$100 for residential and commercial installations, excluding tax, delivery and labor costs.
- WaterSense irrigation controller must be installed at a property receiving potable water service from MMWD. This rebate offer does not apply to recycled water accounts.
- MMWD reserves the right to request proof of installation and/or to inspect the property to verify that the WaterSense irrigation controller is installed, either before or after rebate is paid, and, if necessary, to recover rebated amounts for any WaterSense irrigation controller not installed as required.
- Applicant is responsible for complying with all applicable codes and regulations.
- If existing landscaped area is being renovated and MMWD's Landscape Plan Review Requirements apply, rebate will be paid only when all Landscape Plan Review Requirements are met, as long as funding is available.
- Applicant agrees to allow MMWD to use project photos for outreach and educational purposes.
- Applicant certifies that necessary permissions have been obtained from the property owner, if applicant is not the owner.
- Allow up to 12 weeks for processing.
