Subject:	Question and Comment Concerning Backflow Preventer Test

Dear Board Members (with open copy to Jack Gibson, President),

Since the installation of our new water meter, we are now required to conduct a Backflow Preventer Test annually.

I believe an annual test imposes an unnecessary cost burden to Marin families who have backflow preventers. In the meantime, families that have not upgraded their water meters to include backflow preventers are grandfathered an exempt from any form of compliance.

These backflow preventers are not complicated systems. They are also reliable.

Therefore, I would appreciate if the board would consider changing the test frequency from the current annual test to one test every three years or every four years. This would be similar to a SMOG test for cars. There is simply no need to test the backflow preventer annually, just like there is no reason to test a catalytic converter annually.

An adjustment to a test every three or four years will accomplish the same objective with insignificant negative consequences. On the other hand, this will result in a significant cost savings for your constituents.

Maybe you can do an analysis to determine how many backflow preventers fail annually based on test results and determine the cost for such a failure. Of course, this analysis should not include problems caused by households that do not have backflow preventers in the first place. My guess is that the number of failures is very low, and the cost to society is minimal.

There are currently 106,000 households in Marin County. Assuming an average cost of \$100 per test, that is a \$10,600,000 annual cost savings for Marin households. If only 75% of Marin households have these preventers, that would be a \$7,950,000 annual savings, and so on. And please understand that I am not saying that testing should be cancelled. All I am saying is that they do not need to be tested as frequently as is currently required.

The question is whether an annual test is truly necessary for a backflow preventer. These are fixtures that will last upwards of 50+ years. They are not high technology products that require lots of ongoing maintenance. My guess is that once you have done the analysis, you will see that the benefits to your Marin county constituents by requiring less frequent testing will far outweigh the current annual test requirement.

Given the financial challenges that everyone is facing these days, I hope that you will agree that it would be a socially responsible consideration at least to explore the cost / benefits of requiring annual tests for backflow preventers here in Marin County.
