You are hereby notified of the following changes, deletions, additions, and clarifications to the drawings and specifications and other documents comprising the contract Documents for the Marin Municipal Water District's **FUELBREAK MAINTENANCE AND INVASIVE MANAGEMENT 2021-2023 CONTRACT NO 1948**

1. Section 01000 Special Provisions

Delete the following language from Specification 1.10 D “(1) a rubber-tracked skid steer (minimum 4 ton) with forestry mulching attachment; (3) a water buffalo with minimum 300 gallon tank and 300’ of 1.5” hose; on Section 01000-6.

2. Section 01000 Special Provisions

Delete the following language from Specification 1.1D “Management of Non-natives within fuelbreaks using mechanical methods, which may include masticating with skid steer”. Section 01000-10

3. Section 01000 Special Provisions

Delete the following language from Specification 1.13 “During fire season as defined by the Marin County Fire Department, the Contractor may be required to have a water buffalo with minimum 300 gallon capacity and 300’ of 1.5” hose stationed on the nearest service or paved road, and the equipment listed above shall be within 30 feet of the field crew.” Section 01000-8

4. BID SHEET SCHEDULE

Page IV-a

Replace the BID SHEET SCHEDULE with the attached BID SHEET SCHEDULE – which adds Bid Item c. Laborer (Sawyer).

5. NOTICE INVITING BIDS

Page I & 1-a.

Replace the original bid date of May 28, 2021 with the new bid date of June 7, 2021.

The bidder has examined Addendum No. 1, receipt of which is hereby acknowledged by signing below. The CONTRACTOR shall return Addendum No. 1 with his bid. Failure to acknowledge Addendum No. 1 shall render the bid as nonresponsive and shall be cause for its rejection.

The District does not expressly or by implication guarantee that the actual amount of work or materials will correspond to the estimated amounts.

The District reserves the right to increase or decrease the quantity of work by up to 25% when considered to be in the best interest of the District. The District will not allow price adjustments for differences between actual quantities and bid sheet estimates.
