

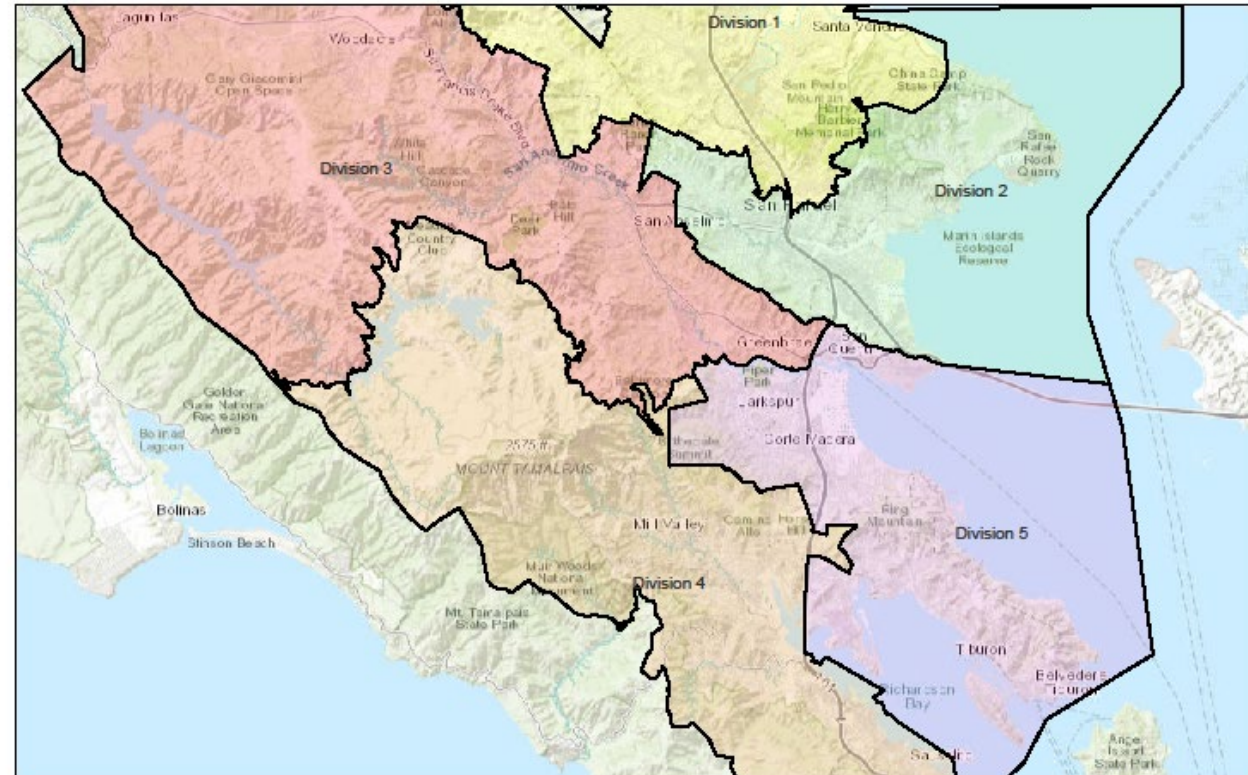

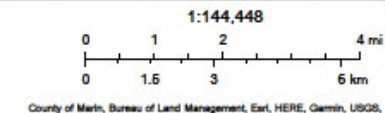

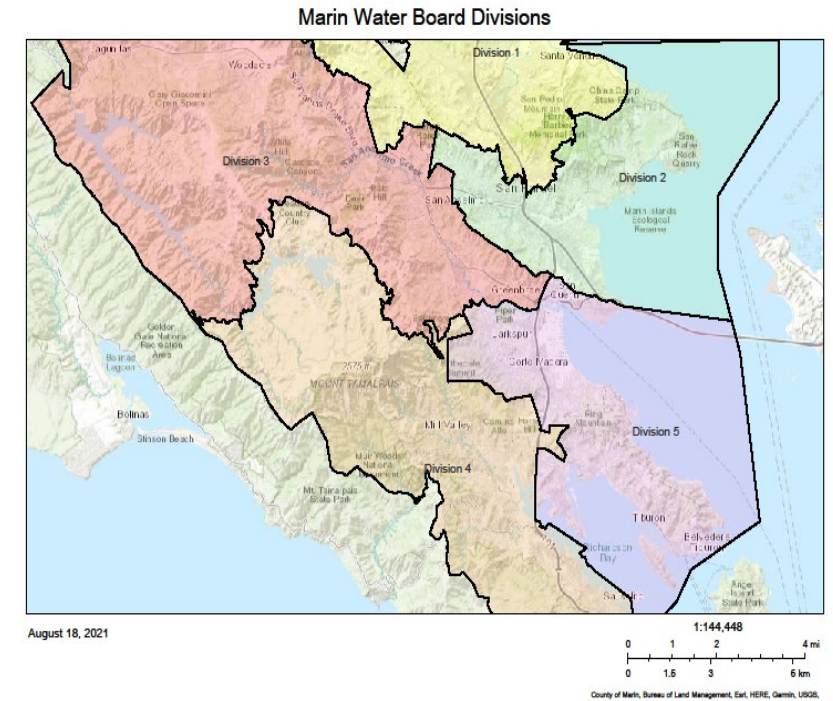

Director Divisions

- A five-member Board of Directors governs our District, with each director elected to represent one of five geographic areas or divisions.

What is Redistricting?

- Redistricting is the mechanism of adjusting director division boundaries every 10 years following the release of U.S. Census data.
- The primary purpose of redistricting is equalizing populations within each division.

Statutory Requirements

- **Water Code section 71540 (Municipal Water District Law of 1911)**

Board shall, by resolution, adjust the boundaries of the any divisions pursuant to Sections 22000 et seq. of the Elections Code.

- **Elections Code section 22000**

Requires the District to adjust the boundaries of any divisions, after the Census, so that the divisions are as far as practicable, equal in population and in compliance with Section 10301 of Title 52 of the United States Code. (Note- This process is different than that used by cities and counties.)

Other Statutory Criteria to Consider

In addition to ensuring near equal population in each division and compliance with voting rights laws, the Board may give consideration to the following factors:

- **(1) topography**
- **(2) geography**
- **(3) cohesiveness, contiguity, integrity, and compactness of territory**
 - Not bypassing nearby populated areas in favor of more distant populated areas
- **(4) community of interests of the division**
 - population that shares common social or economic interests that should be included within a single director division for purposes of its effective and fair representation

(Elections Code section 22000)

2020 Census Data Trends

- Total population increased by 8,211 within the District
- Total population of the District is now 192,961 (up from 184,750 from 2010 Census)
- Average number of people per division increased from 36,950 to 38,592
- Distribution of population remains substantially equal between divisions

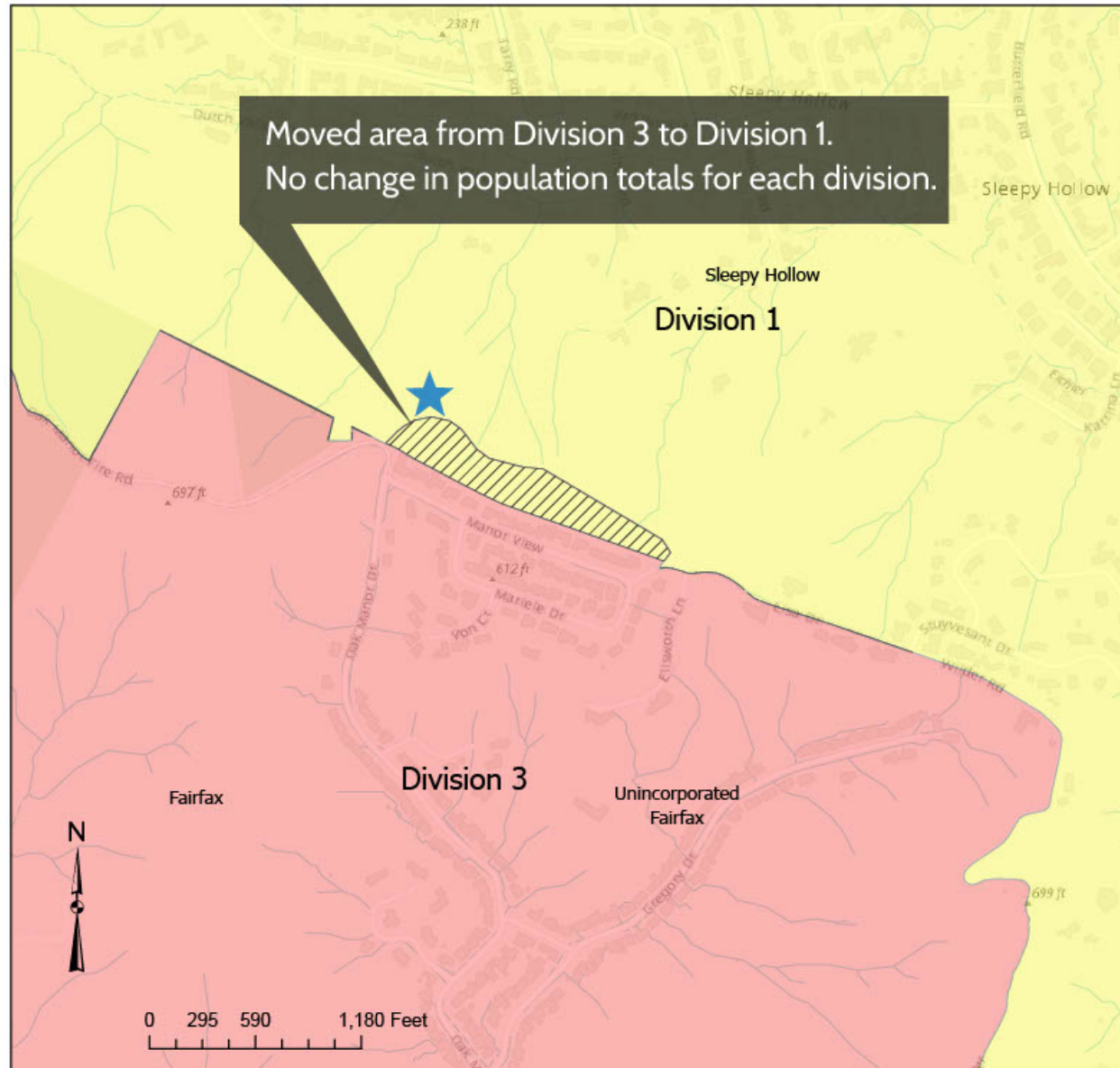

Proposed Census Related Adjustments

- No adjustments based solely on population are required due to “substantially equal” populations existing between divisions.
- A status quo division map can be adopted.
- However, 14 minor adjustments are being proposed to ensure alignment with new census block boundaries.

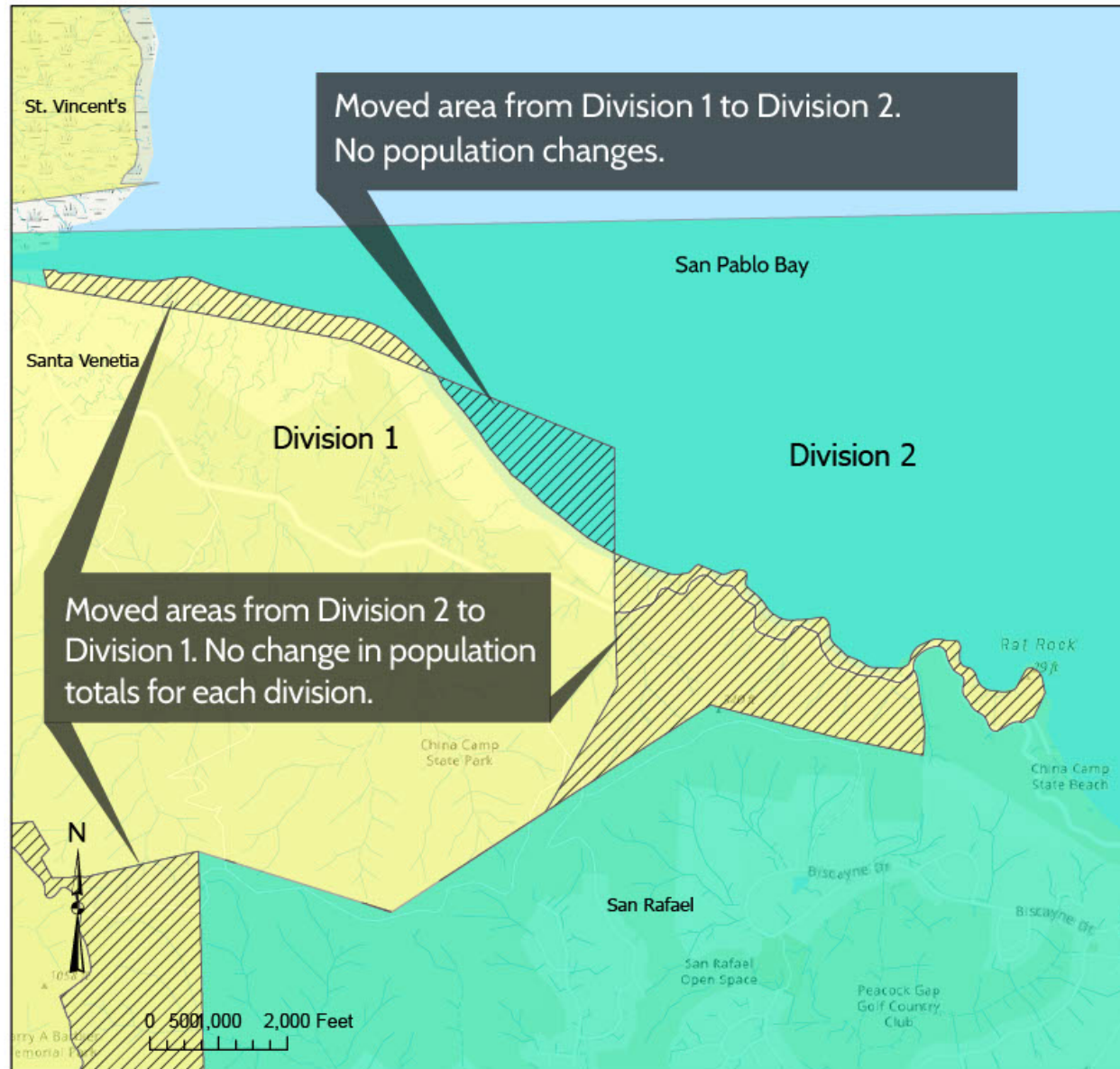

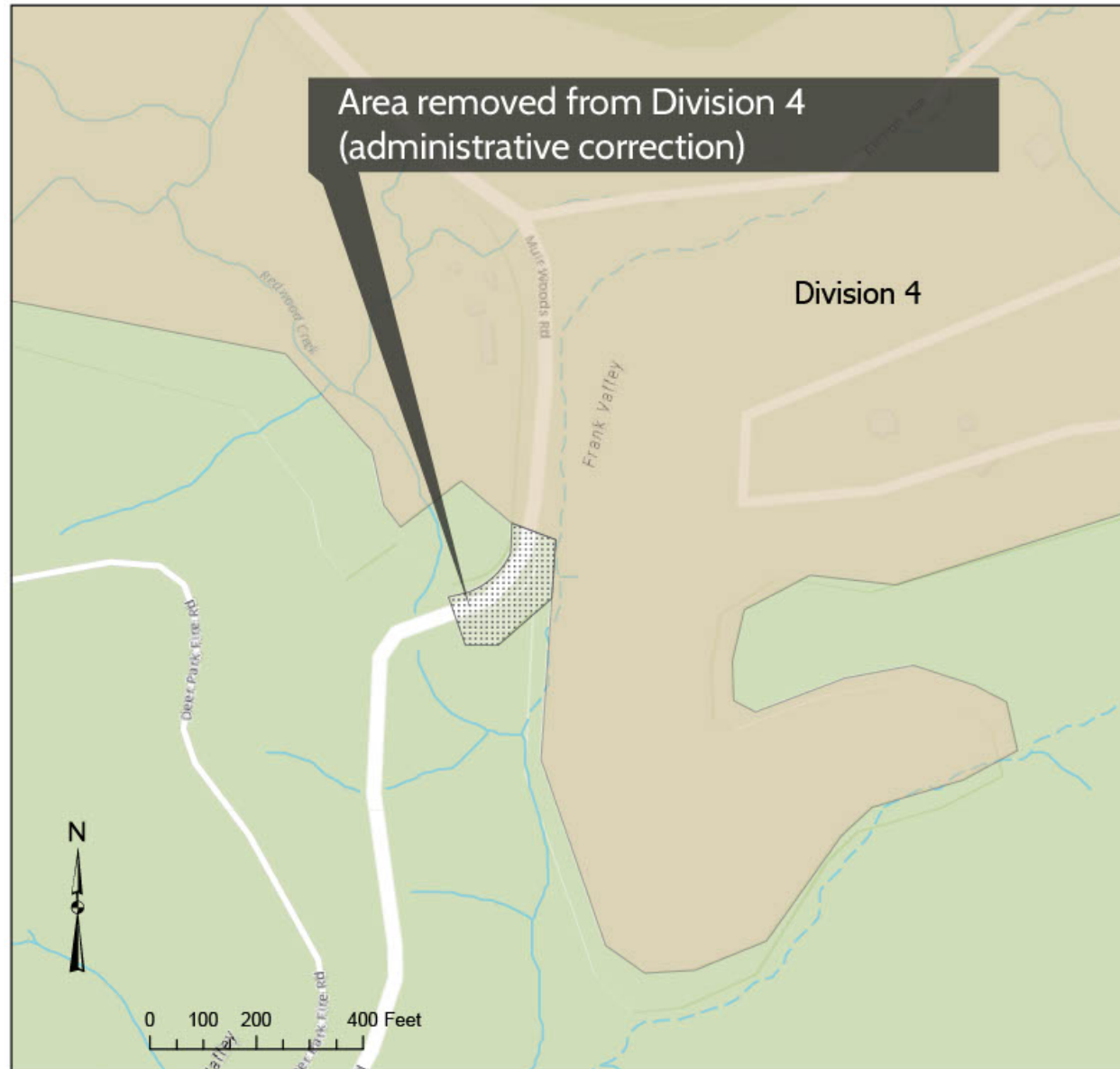
Proposed Non-Census Related Division Boundary Adjustments (LAFCo Adjustments)

- Address parcels annexed into or removed from the District's service area
- Realign District division boundaries with LAFCo service area
- Realign division boundaries with town/city boundaries to the extent possible
- 7 minor adjustments are proposed for these reasons



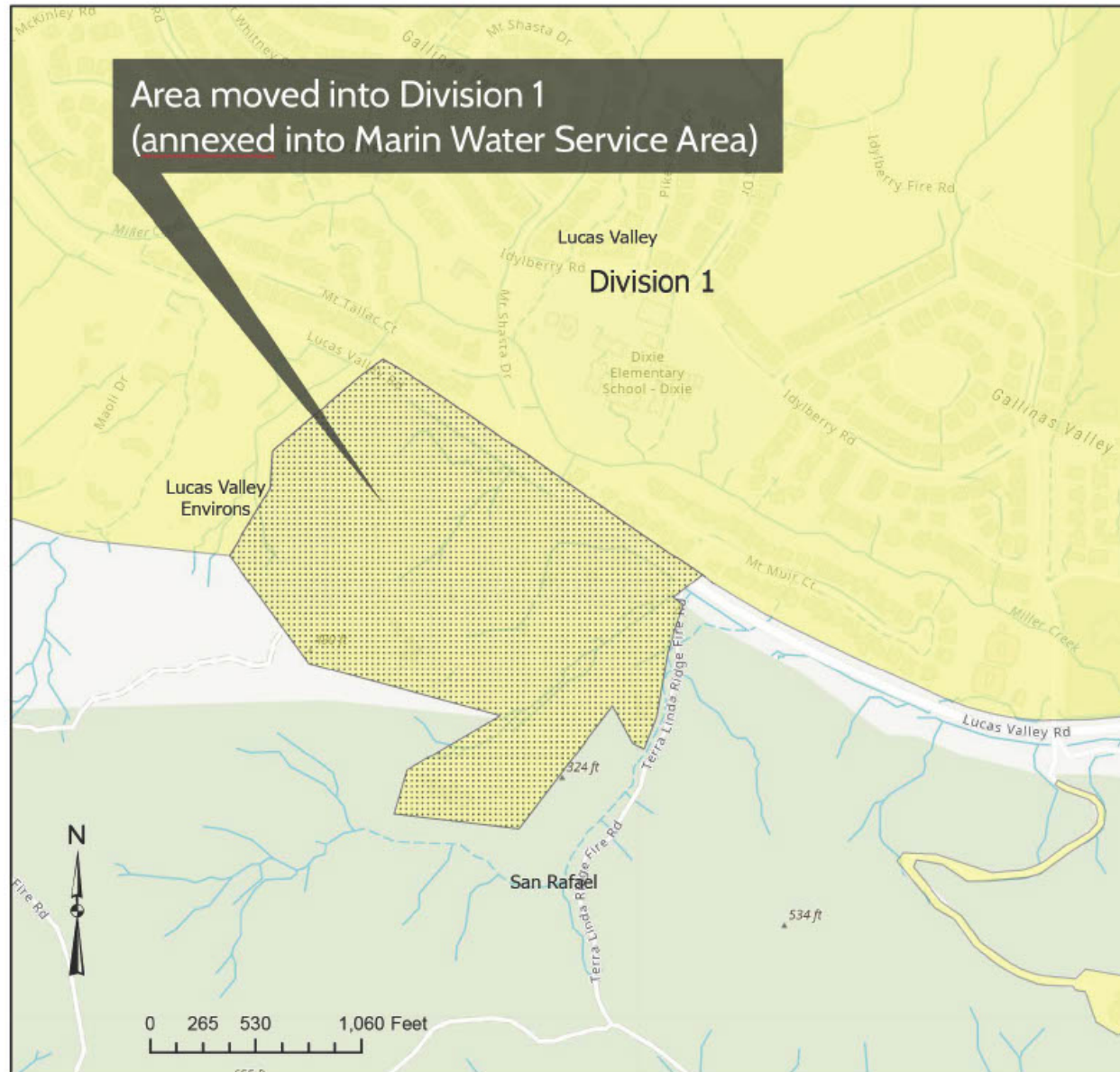

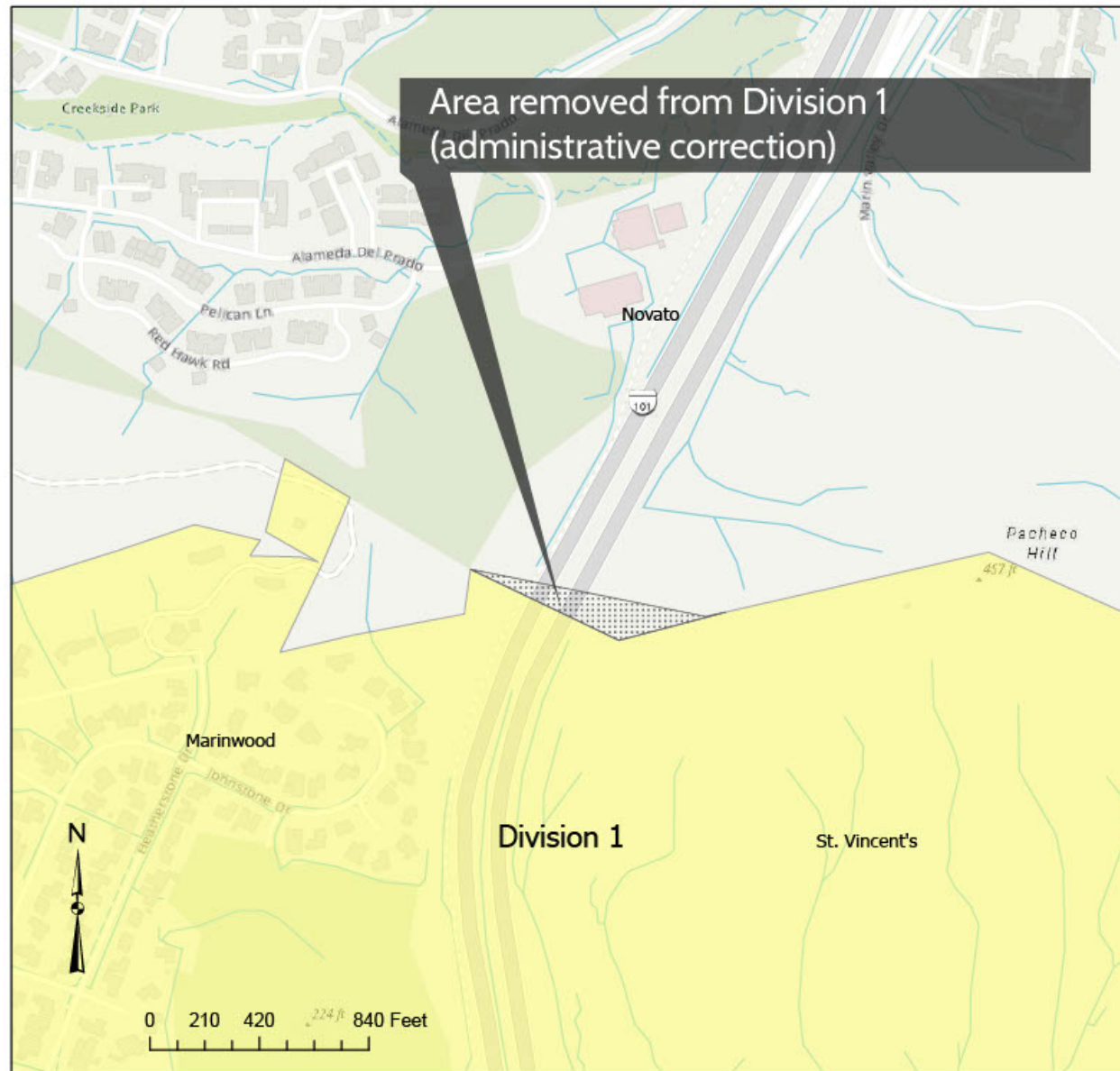

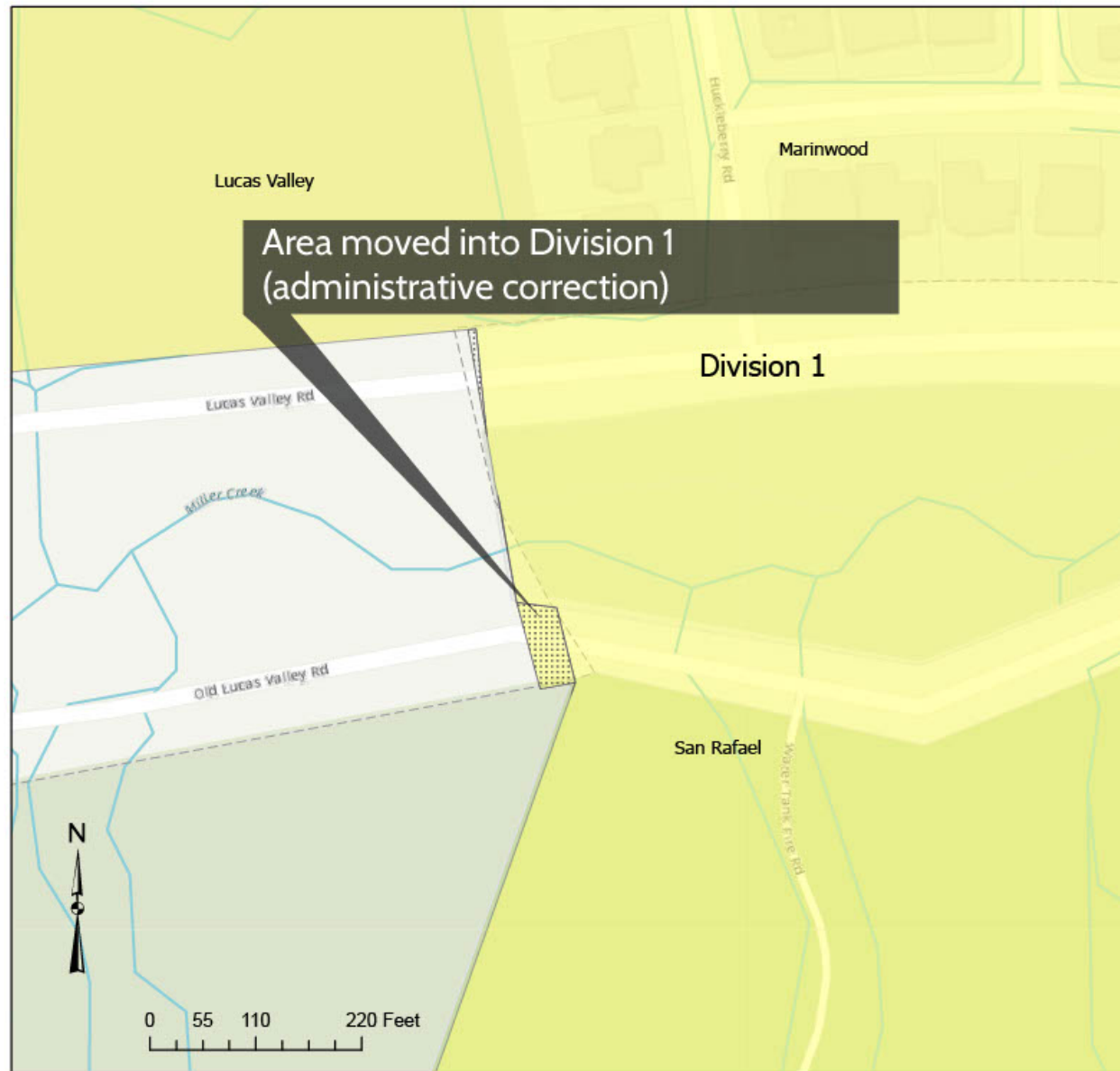
