* Due to the complex nature of calculating the amount diverted for each water right, which involves data that need verification later in the year, a Measurement Method is used to quantify the amount under all separate priorities of rights being exercised pursuant to California Code of Regulations, Title 23, Chapter 2.8, Section 934. The amount diverted during the year will be reported in the annual Report for each separate water right.
