A reservoir gauge measures water level elevation in the reservoir, which is then converted to volume using a depth-capacity rating table.

* Due to the complex nature of calculating the amount diverted for each water right, which involves multiple devices and data that need verification later in the year, a Measurement Method is used to quantify the amount of water diverted under all separate priorities of rights being exercised pursuant to California Code of Regulations, Title 23, Division 3, Chapter 2.8, Section 934. The amount diverted during the year will be reported in the annual Report of Licensee for each separate water right.
