Notice of Upcoming Construction Project in Your Neighborhood



Overview

The Marin Municipal Water District is taking measures to ensure the reliability of the water system in your neighborhood. As you may be aware, there have been several recent main breaks caused by old leak-prone piping on El Camino Drive, Paloma Drive, and Granada Drive over the past year. MMWD is reprioritizing its capital pipeline replacement budget and projects to construct and replace the water mains in Marin Estates. MMWD has been in communication with the Town of Corte Madera Public Works Department to coordinate our pipeline replacement project with the Towns Road Resurfacing Project in the same area. Based on our request, the Town will be postponing its road resurfacing work on the roads included in our water main replacement project until after the water mains have been replaced. MMWD anticipates starting construction of the pipeline during this upcoming winter season and completing work by the summer of 2024. New water mains will be installed on Estrada Lane, Paloma Drive, Granada Drive, El Camino Drive, Sonora Way and Vista Court as identified in the site map below. MMWD and the Town of Corte Madera are committed to completing all work as soon as possible, including the road resurfacing and will continue to collaborate and coordinate how to implement these moving forward.

The new water pipelines installed in your neighborhood will provide a reliable and resilient water pipeline system ahead of the Town of Corte Madera Road Rehabilitation Project. This project will ensure that the integrity of the newly surfaced roads will not be compromised by any future water main leaks. This project will be a collaborative effort between the Marin Municipal Water District and the Town of Corte Madera, and will be carried out in a coordinated manner to help reducing the amount of work, time, and resources required for both projects.

We understand that this may cause some inconvenience and we ask for your patience and cooperation during this time. Long material lead times are affecting the project schedule, which are occurring on a national level. Our team will be working diligently to complete the project as soon as possible and continue to actively coordinate with the Town of Corte Madera on the paving project to help minimize the impact to the community.

Schedule

 Monday through Friday 8:00 a.m. to 5:00 p.m. Preliminary and intermittent work will be performed, including utility locators and surveyors in the neighborhood.

- Please be aware of heavy equipment and construction personnel on the roadway, follow traffic control signs, and reduce your speed.
- MMWD will take all measures possible to minimize inconveniences associated with this project, including noise and traffic delays.

MMWD provides safe, reliable, local drinking water for 187,500 people in ten towns and cities in a 147-square-mile area of the county. The district owns and manages 21,635 acres of watershed land on Mt. Tamalpais and in west Marin. The primary source of water supply is rainfall captured in the district's seven reservoirs, providing 75% of the water consumed each year. The remaining 25% is imported from the Russian River.
